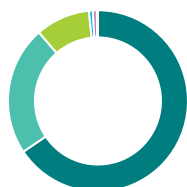

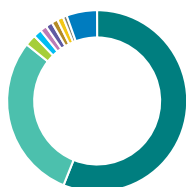

How is the fund invested? (as of October 31, 2025)



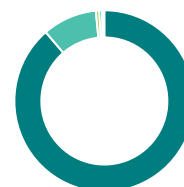

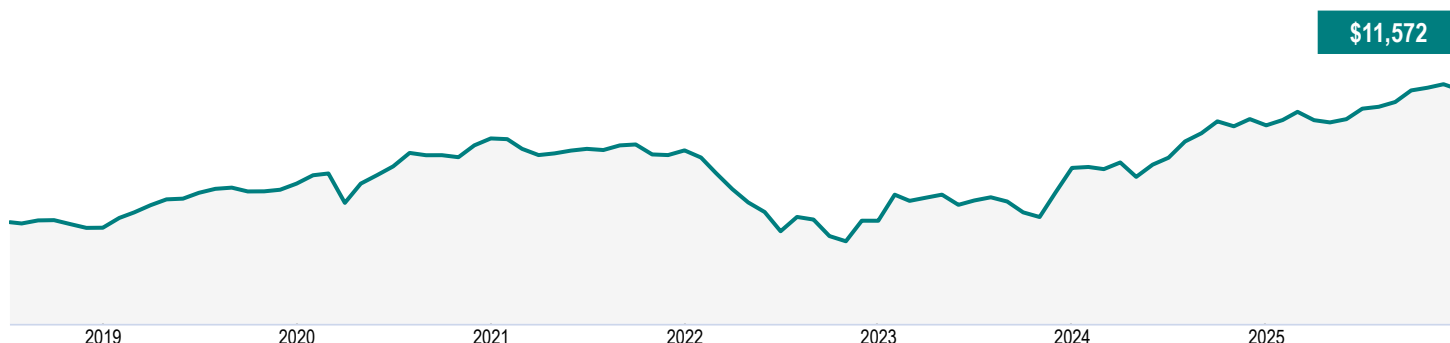
