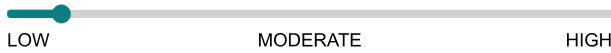

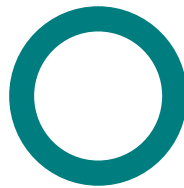

Geographic allocation (%)

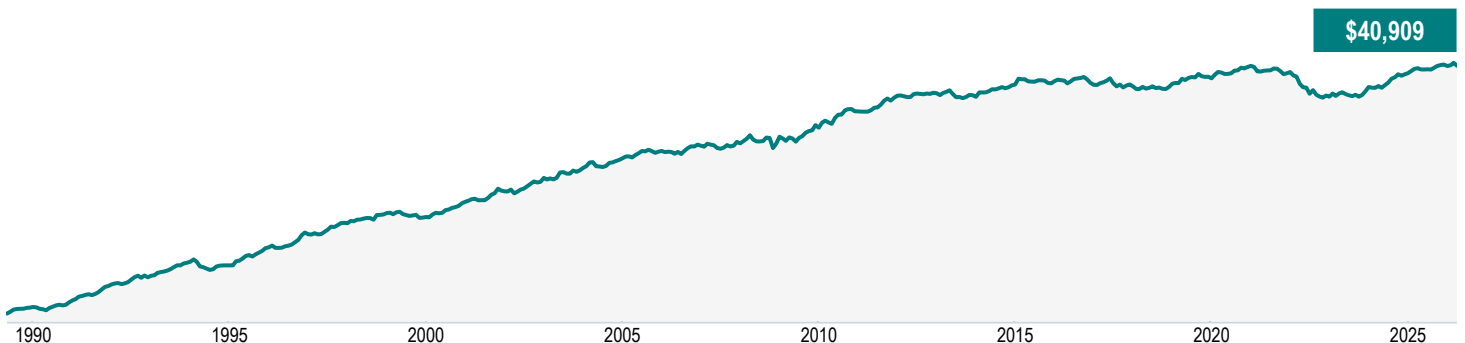
